What is the overall <u>deductible</u> ?	Medical & <u>Prescription Drug Deductible</u> : In-Network: \$3,400 member / \$6,800 family Out-of-Network: \$6,800 member / \$13,600 family Benefits are administered on a Plan Year basis.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this plan begins to pay. Are there services covered before you meet your <u>deductible</u> ?	Yes.
