^{*}Note: If you request a plan change for a February 1st or March 1st effective date, you will be required to pay the 2024 premium on your old plan for the January or January and February coverage month(s). The premium for your newly elected plan will be due January 25th for the February 1st effective date or February 25th for the March 1st effective date.




If you do not complete the renewal process, you will be automatically renewed into the 2024




